Brownell send over an engagement agreement outlining her services with her cost being \$295/hour and her assistant's cost of \$150.00/hour. Moved by Baier and seconded by Hoadley to sign the engagement agreement. Approved.

**CONSERVATION: Maintenance & Activities Report** – Conservation Director Dominic Johnson gave an update to the Board on the following projects: Latrine has been put in, they are ready for dirt work for the shelter house when the weather cooperates, have had enough donations for seven picnic tables, fishing clinic at Lake Orient will be June 8th, seasonal worker will hopefully begin June 1st along with the summer programming employee. **Equipment** – Jonson stated that they have an old piece of equipment, 1977 Dodge that they got in the 1990's that they'd take as a fire rig, which they no longer use it for. Initially, Johnson was wanting to sell it and keep the blade, but the company who can do the brackets for the blade went out of business. Now he would like to sell the whole thing and use that money towards new equipment. Johnson asked if they could do a budget amendment to put that money back into the Conservation's budget to put towards new equipment. Twombly doesn't want to make a promise for next fiscal year and wondered if they had any room in the budget already. Wedemeyer thought that whatever you get for the sale, he could put towards new equipment. Twombly agreed saying that the Board could give him credit for the amount he gets from the Dodge, but that they would need to find the rest of the money in their own budget.
