BOARD COMMITTEE REPORT UPDATES: Hoadley reported that Crossroads is selling their building to the Creston Hospital. Wedemeyer did not have any updates. Twombly reported that the Regional Health Board will only have 1 Supervisor from the 4 counties serve on the Board and the Taylor County member will serve the 4 counties. Baier reported that EMA has a new truck on the way and has been super busy. Midwest Partnership is business as usual. Walker reported via telephone that SICOG is still taking applications for grants and forgivable loans at City Hall, there is no restriction on state ones and have to have filed with FEMA and their insurance company. Hoadley mentioned they have to stay there 5 years or pay the loan back if they sell the house.

NEW HIRE and SHERIFF UPDATE: SHERIFF JEFF VANDEWATER: Moved by Twombly and seconded by Hoadley to approve the new hire Paula Bates for dispatcher/jailer. Approved. RAGBRAI went well yesterday for the most parts. There were a few wrecks. County dispatch was very busy along with deputies. ICAP has not said what they will pay for yet with the tornado damage on the jail. The state radio tower may have to come down but they can do the ICN link to get hooked up at a fee. Hoadley asked if we will continue to send prisoners to Dallas County. Sheriff meets with FEMA today, but the heat and cooling units could go out anytime and those units take 3 or 4 months to get. Sheriff is waiting to hear from ICAP, they have been hit hard. Chief Deputy Algreen's car has been mostly taken care of and hashed out.

SECONDARY ROADS: ENGINEER KAUFFMAN: Twombly moved and Wedemeyer seconded to Award Resolution for FM Payment Marking Project FM-C001(I26)-55-01. Rollcall vote Baier aye, Twombly aye, Wedemeyer aye, and Hoadley aye. Approved. Report of Maintenance and Activities:

Working on Richland project, Murphy's starting on decking and working with GMU on hauling dirt. Engineer Kauffman will be posting a couple of jobs soon and do internally 1st then outside due to 2 resignations. These 2 were culvert crew.
