APPROVE ENGINEER DRAWINGS FOR GRANDSTANDS: Moved by Wedemeyer and seconded by Walker to approve the Engineer drawings for the Fair Grandstands project. Approved.

COMPREHENSIVE PLAN DISCUSSION: The Board discussed whether to move forward with a comprehensive plan along with zoning guidelines. Supervisor Hoadley stated that industrial zoning would provide clear guidelines and allow public input. Hoadley would be in support of zoning that protects our agriculture and farmers. Supervisor Walker stated he was concerned about the zoning permits and the administration part of putting in zoning. Supervisor Wedemeyer doesn't think there is a reason to update the comprehensive plan unless we want to move forward with zoning. Supervisor Walker stated that it would help reinforce the ordinances that we already have in place for wind turbines and solar. Moved by Hoadley to move forward with a comprehensive plan through SICOG. Supervisor Christoffersen voiced his concern that the process might become more complex than they are wanting after input from the public. The Board discussed the need to consult with other counties and whether to handle the process internally or through a committee. Hoadley withdrew her motion and the Board opted to table the discussion for next week to gather more information.
