IOWA250 COMMITTEE: Auditor Berg stated that she had been contacted by the State Iowa250 Committee who asked that each County have a committee to plan events in celebration of the 250th anniversary of our Country. The Board discussed the options and Supervisor Wedemeyer stated that he would reach out to the County's tourism group to see if they would be interested.

GENERAL RELIEF APPLICATION: Moved by Walker and seconded by Wedemeyer to approve the General Relief Application. Approved.

CHILD ABUSE PREVENTION GRANT DRAW DOWN: Moved by Walker and seconded by Wedemeyer for Auditor Berg, as contract administrator, to sign the Child Abuse Prevention Grant Draw Downs. Approved.

COMPREHENSIVE PLAN DISCUSSION: The Board discussed the comprehensive plan and zoning. Supervisor Wedemeyer stated that he had spoken with Guthrie County and they contract with Region 12 to do the zoning administration. Wedemeyer thinks if we make a decision on doing both a comprehensive plan and zoning, that it would give us a direction with how we want to do our comprehensive plan. Supervisor Hoadley stated that she has water concerns and think we need to have something in place to protect that from people coming in and building, but Wedemeyer thought that that would be a DNR responsibility. Supervisor Walker thinks the Board should just do a comprehensive plan for now and wait on zoning as he is not in favor of it at this time. Supervisor Christoffersen thinks it is important to get the comprehensive plan in place to reinforce the ordinances that we have in place now and would be in favor of zoning at some point. Supervisor Baier is in favor of moving forward with the comprehensive plan and may be in favor of minimal zoning going forward. Moved by Baier and seconded by Hoadley to move forward with the comprehensive plan solely. Wedemeyer, nay. Approved. Moved by Hoadley and seconded by Wedemeyer to move forward with SICOG to do the comprehensive plan for the County. Approved.

CONSERVATION – TRUCK PURCHASE: This will be discussed at a later date.

ENGINEER: New Hires – Moved by Hoadley and seconded by Walker to approve the hire of Evan Huddleson and Lance McFarland at \$24.49 effective June 15, 2025. Approved. **Maintenance & Activities Report –** Engineer Kauffman gave an update to the Board on the following projects: Murphy working on Summerset 6 Bridge, Govig coming in July for W1 Lee, N27 Eureka Bridge, working on sign inventory, FEMA project has moved to state for approval, working on bridge inventory – we have the lowest number of bridges we've ever had at 264, discussed future TIF projects, quarry has been out of rock so they've been hauling out of stockpiles
