Sign Front Page of Plans for Rose Acres Road Resurfacing Project FM-C001(134)-55-01 This 1 is shared 50/50 with Guthrie and we are the lead on this project. Wedemeyer moved and Christoffersen seconded for Chair to sign. Approved. Sign Front Page of Plans for the W9 Lincoln: This is a TIF project and Engineer Kauffman anticipates a 3 month closure. Moved by Hoadley and seconded by Walker for Chair to sign. Approved. Maintenance & Activities Report – Engineer Kauffman gave updates to the Board on the following projects: been working with MidAmerican with Orient on submitting a rough plan on paving road mile from Highway 25 over to Orange and North 1/2 Mile on Orange. Hoadley said they should pay 100% for it and Kauffman said that is the idea. We would replace all culverts, stabilization and asphalt. They are looking at up to 400 people working there during construction. They would like the road done before they start their construction. Kauffman's contact has changed and she said she would be willing to come to a board meeting for the road use agreement and to answer our questions. We will plow snow as our regular routine but they will do snow removal as part of the agreement because they will plow as needed. Sawyer has been working on the plans, we will use DOT specs and provide alternate ways to adjacent landowners. Herbergers is working in Eureka. Kauffman went to Adams County yesterday for a conference, pouring a bridge deck tomorrow there and he and Pickrell will help with that. They will be billed for that. Walker asked about a bridge on 310th and Kauffman is waiting on another company to respond, if don't hear anything in the next 2 days we will move forward. Walker went on a solar tour near Dexter and said it was a good tour.
